**General Show Info**

**Entries:** Entries will be accepted for sixty-five riders. Others will be waitlisted. Secretary will notify you once your entry has been accepted.

**Schooling Day:** June 20<sup>th</sup>: Schooling is available at \$30.00 per horse and open from 3-6pm.

**Show Day:** June 21<sup>st</sup>: Rings will open at 7:30am. No riding will be available in the show rings in the morning. Hand walking is available 30 min prior to show time. Schooling on day of the show is available at \$50.00 per horse if you have not entered two or more classes.

No classes can be added the day of the show.

**Stabling:**

Saturday day/overnight (**NO** schooling) and Sunday day: \$85.00.

**IF** you are schooling on Saturday add \$30.00 (Total \$115.00)

Sunday ONLY stall: \$60.00

Shavings: \$9.00.

Horses can arrive after 2:00pm on June 20<sup>st</sup> and no later than 6pm.

No refunds after closing date.

**Awards:** Show themed Ribbons first through sixth place.

Six high percentage awards: Intro Jr & Adult, Training Jr & Adult, Upper level Jr & Adult.
